The Adopter(s) understands, acknowledges and agrees that the dog has been either spayed or neutered unless the dog's age, health or physical and/or emotional condition dictate that temporary/permanent delay is in the dog's best interest.

4. ADOPTER(S) AGREES TO THE FOLLOWING PROVISIONS:

- Adopter(s) agrees and understands that True Heart MinPin Rescue shall have the right to contact any veterinarian that has examined and/or treated the dog in regards to the dog's health and care.
- Heartworm/Flea preventatives and necessary inoculations at the intervals advised by the veterinarian will be given.
- Adopter(s) insure the dog will not wear a pinch collar, shock collar, or any similar article at any time.
- Adopter(s) warrants the dog will live only inside the main living quarters in residence with Adopter(s). At no time will the dog be maintained in an area where its health is endangered by weather conditions.
- Adopter(s) insures that under no circumstances whatsoever will the dog be subjected to cosmetic or elective surgery of any kind (no tail docking, ear cropping, or other)
- Adopter(s) agrees to have the dog under control when not on the confines of Adopter(s) property.
- Adopter(s) agrees not to abuse or neglect the dog and will provide adequate, nutritious food, water and shelter at all times.
- If for any reason Adopter(s) cannot keep the dog, Adopter(s) agrees to notify a True Heart Representative of the availability of the dog and to return the adopted dog upon request. The Dog will not be surrendered to a shelter, another rescue or other person(s).
- Adopter(s) understands and agrees that any failure to perform the foregoing agreement will constitute a breach of this agreement. In the event of any breach of agreement, Adopter(s) authorizes a True Heart Representative to reclaim both possession and ownership of the dog.
- Adopter(s) agrees to give a True Heart Representative visitation rights to ensure that the terms of this adoption agreement are being observed.
